Even the director of the impious rites of Medmenham found it convenient to have "a form of godliness." His heathenish proceedings on the enshrinement of Paul Whitehead's heart, in 1775, have been described by several writers. In 1781, shortly before his Lordship's death, Whitehead's ghost is said to have appeared to him and several members of his household. See Cowper's letter to Unwin, 24 Nov., 1781 (Southey's Cowper, Vol. IV. p. 147). Cowper doubtless received the information from Lady Austen, who was connected with the Dashwood family. The heart disappeared in 1839.
